- The company's operations during the year predominantly comprises of only one segment Textiles (Yarn & Knitwear).
- 3. The company has commenced generation of power in one of its hydro power unit for captive consumption.
- 4. Auditors remarks on the accounts for the year ended 31st March, 2010: (a) Non provision against overdue debts of Rs. 1903 lacs since in the opinion of the management, these debts are good for recovery; Management Response: There is no significant change in the status of these debts. (b) Non provision for diminution in the value of investment in subsidiary; Management Response: Investments being long term in nature, hence diminution in value, being temporary, is not considered. (c) Managerial remuneration paid to the Managing Director is pending for approval of the Central Government; Management Response: Company's application is pending for approval with the Central Government.
- 5. During the quarter, the company has applied for rework of existing CDR package before the CDR EG, which is pending for approval. Impact of the same, if any will be accounted for as & when approval is received.
- 6. Provision for Current Tax and Deferred Tax will be made at the year end.
- 7. The proceeds for preferential issue of convertible warrants is being utilized for the purposes as stipulated.
- Previous period figures have been regrouped and/ or re-arranged wherever necessary to make their classification comparable with current period.
- The Company has received eight grievances from the shareholders and the same have been resolved and replied during the quarter, hence no grievance was pending at the start and end of the quarter.
